### **DETAILS OF EDUCATIONAL QUALIFIATION**

**Essential Qualification as on 01-June, 2023:-** Graduation from a recognized University / Institute in India.

The candidate must have a proficient knowledge of Hindi and English language.

### **REMUNERATION**

The Clerk / Cashier may be absorbed as an Assistant Gd-2 (Clerk / Cashier) on a pay scale of 11,400-740/10-18,800-EB-840/15-31,400 (an aggregate of approx. Rs. 27,000.00 per month) after satisfactory completion of probation for a period of two years in the same scale.

### SECURITY (Refundable, Term & conditions will be applied)

Candidates are advised to carefully note that they will be required to submit security amount of Rs. 25,000/- (Rs.Twenty five thousand only) at the time of of joining.

#### **IDENTITY VERIFICATION**

"In the examination hall as well as at the time of interview, the call letter along with original and a photocopy of the candidate's currently valid photo identity (bearing exactly the same name as it appears on the call letter) such as PAN Card/ Passport/ Permanent Driving Licence/ Voter's Card/ Bank Passbook with photograph/ Photo identity proof issued by a Gazzetted Officer on official letterhead along with photograph / Photo identity proof issued by a People's Representative on official letterhead along with photograph / valid recent Identity Card issued by a recognized College/ University/ Aadhar card/ E-Aadhar Card with a photograph/ Employee ID/ Bar Council Identity Card with photograph should be submitted to the invigilator for verification. ## DETAILED GUIDELINES / PROCEDURES FOR APPLICATION REGISTRATION PAYMENT OF FEES

### A. DOCUMENT SCAN AND UPLOAD

Candidates can apply online only from July 08, 2023 to July 22, 2023 and no other mode of application will be accepted.

### IMPORTANT POINTS TO BE NOTED BEFORE REGISTRATION

Scan their:

(i) Photograph (4.5cm × 3.5cm)

Signature (with black ink)

Left thumb impression (on white paper with black or blue ink)

A hand written declaration (on a white paper with black ink) (text given below)

- (i) Signature in CAPITAL LETTERS will NOT be accepted.
- (ii) The left thumb impression should be properly scanned and not smudged. (If a candidate is not having left thumb, he / she may use his / her right thumb for applying.)
- (iii) The text for the hand written declaration is as follows -
  - "I, \_\_\_\_\_ (Name of the candidate), hereby declare that all the information submitted by me in the application form is correct, true and valid. I will present the supporting documents as and when required."
- (v) The above mentioned hand written declaration has to be in the candidate's hand writing and in English only. If it is written and uploaded by anybody else or in any other language, the application will be considered as invalid.

(vi) Keep the necessary details / documents ready to make Online Payment of the requisite application fee / intimation charges.

Have a valid personal email ID and mobile no., which should be kept active till the completion of this Recruitment Process. Bank may send intimation to download call letters for the Examination etc. through the registered e-mail ID. - 2. To register application, choose the tab "Click here for New Registration" and enter Name, Contact details and Email-id. A Provisional Registration Number and Password will be generated by the system and displayed on the screen. Candidate should note down the Provisional Registration Number and Password. An Email & SMS indicating the Provisional Registration number and Password will also be sent.
- 3. In case the candidate is unable to complete the application form in one go, he / she can save the data already entered by choosing "SAVE AND NEXT" tab. ### B. PAYMENT OF FEES

### **Guidelines for scanning and Upload of Documents**

### Photograph Image: (4.5cm × 3.5cm)

- Photograph must be a recent passport style colour picture.
- Make sure that the picture is in colour, taken against a light-coloured, preferably white, background.
- Look straight at the camera with a relaxed face
- If the picture is taken on a sunny day, have the sun behind you, or place yourself in the shade, so that you are not squinting and there are no harsh shadows
- If you have to use flash, ensure there's no "red-eye"
- If you wear glasses make sure that there are no reflections and your eyes can be clearly seen.
- Caps, hats and dark glasses are not acceptable. Religious headwear is allowed but it must not
  cover your face.
- Dimensions 200 x 230 pixels (preferred)
- Size of file should be between 20kb-50 kb
- Ensure that the size of the scanned image is not more than 50kb. If the size of the file is more than 50 kb, then adjust the settings of the scanner such as the DPI resolution, no. of colours etc. during the process of scanning.

### Signature, left thumb impression and hand-written declaration Image:

- The applicant has to sign on white paper with Black Ink pen.
- Dimensions 140 x 60 pixels (preferred)
- Size of file should be between 10kb 20kb for signature and 20kb 50kb for left thumb impression.
- Ensure that the size of the scanned image is not more than 20kb

The applicant has to put his left thumb impression on a white paper with black or blue ink.

- File type: jpg / jpeg
- <u>Dimensions:</u> 240 x 240 pixels in 200 DPI (Preferred for required quality) i.e
  - 3 cm \* 3 cm (Width \* Height)
  - File Size: 20 KB 50 KB

### The applicant has to write the declaration in English clearly on a white paper with black ink.

- File type: jpg / jpeg
- <u>Dimensions</u>: 800 x 400 pixels in 200 DPI (Preferred for required quality) i.e
  - 10 cm \* 5 cm (Width \* Height)
  - File Size: 50 KB 100 KB
- The signature, left thumb impression and the hand written declaration should be of the applicant and not of any other person.
- If the Applicant's signature on the attendance sheet or Call letter, signed at the time of the examination, does not match the signature uploaded, the applicant will be disqualified.
- Signature / Hand written declaration in CAPITAL LETTERS shall NOT be accepted.

### Scanning the documents:

- Set the scanner resolution to a minimum of 200 dpi (dots per inch)
- Set Colour to True Colour
- File Size as specified above
- Crop the image in the scanner to the edge of the photograph / signature / left thumb impression
  / hand written declaration, then use the upload editor to crop the image to the final size (as specified above).
- The image file should be JPG or JPEG format. An example file name is:
  - Image01.jpg or image01.jpeg. Image dimensions can be checked by listing the folder files or moving the mouse over the file image icon.

Note:

Intimation for downloading call letter will also be sent through e-mail / SMS. Once the candidate clicks the relevant link, he / she can access the window for call letter download. The candidate is required to use (i) Registration Number / Roll Number, (ii) Password / Date of Birth for downloading the call letter. Candidate needs to affix recent recognizable photograph on the call letter preferably the same as provided during registration and appear at the examination centre with (i) Call Letter (ii) Photo Identity Proof as stipulated in this advertisement and also specified in the call letter and (iii) Photocopy of the same Photo Identity Proof as brought in original.

### At the Examination Centre:

Candidates are required to bring the following to the examination centre:

- a. <u>Print out of Call Letter</u> (which has to be downloaded by the candidate using the registration number and password obtained at the time of registration of online application). A recent passport size photograph of the candidate has to be affixed on the Call Letter.
- b. Candidates are required to carry with them their currently valid photo identity proof (in original) and photocopy thereof, failing which they will not be allowed to appear for the test.

- 1. The examination will be conducted online in venues given in the respective call letters.

# ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT/ USE OF UNFAIR MEANS

Candidates are advised in their own interest that they should not furnish any particulars that are false, tampered with or fabricated and should not suppress any material information while submitting online application. At the time of examination, interview or in a subsequent selection procedure, if a candidate (is or has been ) found guilty of –

- i) using unfair means or
- ii) impersonating or procuring impersonation by any person or
- iii) misbehaving in the examination / interview hall or disclosing, publishing, reproducing, transmitting, storing or facilitating transmission and storage of contents of the test(s) or any information therein in whole or part thereof in any form or by any means, verbal or written, electronically or mechanically for any purpose or
- iv) resorting to any irregular or improper means in connection with his / her candidature or
- v) obtaining support for his / her candidature by unfair means, or

- vi) carrying mobile phones or similar electronic devices of communication in the examination / interview hall, such a candidate may, in addition to rendering himself / herself liable to criminal prosecution, be liable :
  - a. to be disqualified from the examination for which he / she is a candidate
  - b. to be debarred either permanently or for a specified period from any examination conducted by the bank
  - c. for termination of service, if he / she has already joined the Bank.

### **OTHER CLAUSES**

- 1. The possibility of occurrence of some problem in the administration of the examination cannot be ruled out completely which may impact test delivery and / or result from being generated. In that event, every effort will be made to rectify such problem, which may include movement of candidates, delay in test. Conduct of a re-exam is at the absolute discretion of test conducting body. If in the analytical procedure adopted by the Bank in this regard, it is inferred / concluded that the responses have been shared and scores obtained are not genuine / valid, the Bank reserves right to cancel the candidature of the concerned candidates and the result of such candidates (disqualified) will be withheld.

The The Kurmanchal Nagar Sahkari Bank Ltd. shall then give appointments to the selected candidates.

### **Process for Arriving at Scores**

The Scores of Online Examination are obtained by adopting the following procedure:

- (i) Number of questions answered correctly by a candidate in each objective test is considered for arriving at the Corrected Score after applying penalty for wrong answers.
- (ii) The Corrected Scores so obtained by a candidate are made equivalent to take care of the minor difference in difficulty level, if any, in each of the objective tests held in different sessions to arrive at the Equated Scores\*
  - \* Scores obtained by candidates on any test are equated to the base form by considering the distribution of scores of all the forms.
- (iii) Test wise scores and scores on total is reported with decimal point upto two digits.

Note: Cutoffs are applied in two stages:
