RECRUITMENT OF MERITORIOUS SPORTS PERSONS IN CENTRAL TAX AND CUSTOMS DEPARTMENT – HYDERABAD ZONE-2024

The Principal Commissioner of Central Tax, Hyderabad invites applications for recruitment of meritorious sports persons in all 65 sports disciplines notified by DoP&T. Post wise number of vacancies for recruitment are as mentioned in the table below:

- **2**. The application form along with terms and conditions and instructions to the candidates should be downloaded from the Central Board of Indirect Taxes Departmental official website http://www.cbic.gov.in and from the Central Tax, Hyderabad website http://cgsthyderabadzone.gov.in.
- **3.** The application form duly filled in all respects should be submitted in a closed cover super scribed with words. "Application of meritorious sports person in Central Tax and Customs Department 2024" and addressed to:

4. The applications may be sent either by post or in person so as to reach the above address within office hours on or before 19.08.2024. For candidates domiciled in North-Eastern States, Andaman & Nicobar Islands, Lakshadweep, Jammu & Kashmir, the application should reach the above address by 26.08.2024. The applications received after last date will not be entertained under any circumstances.

5. TERMS & CONDITIONS

- 1. Candidates should read the below mentioned terms & conditions and instructions carefully before filling up the form.
 - (a) The application should be strictly as per the pro-forma prescribed. Application not accompanied by the prescribed forms and copies of relevant merit/participation certificates will be liable for rejection.
 - (b) Only one application should be submitted by the candidate. If any candidate submits more than one application, all such applications will be summarily rejected and the candidate will not be eligible.
- 2. The application should be filled up in Block Letters in English using ink pen or ballpoint pen preferably in **Black ink**.
- 3. Along with the application (Annexure-II), the following mentioned forms duly filled up and signed by the respective sports authorities as mentioned in the forms (Enclosed as Annexure-A) should be submitted.

6. ELIGIBILITY CONDITIONS

(i). AGE LIMIT: 18 to 27 years as on 19.08.2024. Relaxation up to 3 years for OBC candidates and 5 years in case of SC/ST Candidates. For exceptional achievements in Sports/Game and those candidates who fulfil all other eligibility conditions with necessary certificate, age will be relaxable up to 5 years and 10 years in the case of SC/ST.

7. SPORTS ELIGIBILITY:

The proficiency will be evaluated only on the basis of forms and certificates submitted for the participation in recognized tournaments / events in the calendar year 2023, 2022, 2021, 2020 and 2019 for which details should be furnished in Annexure-I. Certificates of participation/achievements for which concerned forms issued by concerned Authorities are not enclosed, will not be considered for evaluating the proficiency. The tournaments/events will be evaluated in the following descending order of importance.

Order of Preference:

- (a) First preference to those candidates who have represented the country in an International Competition with the clearance of the Department of Sports, Ministry of Youth Affairs and Sports.
- (b) Next preference may be given to those who have represented a State U.T. in the Senior or Junior level National Championships organized by the National Sports Federations recognized by Department of Sports, Ministry of Youth Affairs& Sports or National Games organized by Indian Olympics Association and have won medals or positions up to 3rd place. Between the candidates participating in Senior and Junior National Championships/games, the candidates having participated and won medal in Senior National Championship should be given preference.
- (c) Next preference may be given to those, who have represented a University in an Inter-University competition conducted by Association of Indian Universities/Inter University Sports Board Or Khelo India University Games conducted with authorization of Department of Sports, Ministry of Youth Affairs and Sports and have won medals or positions up to 3rd place in finals.
- (d) Next preference may be given to those who have represented a State/UT in Khelo India Youth Games (age category above 18 years) or Khelo India Winter Games or Khelo India Para Games conducted with authorization of Department of Sports, Ministry of Youth Affairs and Sports and have won medals or positions up to 3rd place in finals.
- (e) Next preference may be given to those who have represented the State Schools in the National sports/games for Schools conducted by the All-India School Games Federation and have won medals or positions up to 3rd place.
- (f) Next preference may be given to those who represented a State/Union Territory/University/State Schools Teams at the level mentioned in categories (b) to (e) but could not win a medal or position, in the same order of preference.

9. SELECTION OF THE CANDIDATES

The applications will be scrutinized and suitable candidates will be shortlisted for further selection process. Department reserves the right to decide the number of candidates to be called for field trials based on the credentials of the candidates. The eligible candidates will have to appear in the field test relevant to Sports discipline.

Success in the above tests confers no right to appointment unless the department is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respects for appointment to the post.

- 10. Field trial will be conducted to check the fitness levels and performance of the candidates. Field trials will carry marks and will also be counted for ranking purpose. In case any candidate is unable to take the fitness test for any reason whatsoever or having taken the test is not found fit, the candidates would not be considered for the post. The current form will be evaluated based on the year of participation in recognized tournaments/events in the calendar year 2023, 2022, 2021, 2020 and 2019 for which the details should be furnished as per Annexure-I.
- 11. The shortlisted candidates will be called for written test. The written examination for the post of Tax Assistant/Stenographer/Havaldar will be in English/Hindi and will consist of objective type multiple choice questions in General Knowledge, Reasoning, Numerical/Quantitative Aptitude, General English and General Awareness. Written test is purely qualifying in nature. The candidates applying for Tax Assistants posts will be required to take a data entry test for 15 minutes. The candidates applying for the post of Stenographer Gr-II post will be required to take skill test for stenography as per prescribed norms. Based on the aggregate marks obtained in the field trials and merit certificates, the candidates will be ranked for selection.
- **12.** The field trials and written exam will be held in Hyderabad. The selected candidates will be required to appear for the same at their own expenses on the dates and time to be informed later.
- **13.** The applicant should enclose attested copies of the following certificates.
- (i) Matriculation/SSC or equivalent certificate for proof of age
- (ii) Education qualification certificates
- (iii) Sports/games certificates as mentioned in Annexure-I.
- (iv) Relative Forms for Sports/games certificates as mentioned in Annexure-A.
- (iv) Caste certificate in proof of caste(if applicable).
- 14. Forms issued by Sports Federation/Associations other than those recognized by the Ministry of sports and youth welfare shall not be considered.
- 15. Sports persons who are already employed in Central Government or State Government or PSU should submit an NOC from the present employer which should be enclosed with the application.
- 16. The selected candidates will be on probation for a period of 2 years or such period as per the extant instructions of the Government of India. Their participation in the tournaments/meets on behalf of the Department will also be a deciding factor in the declaration of their probation. The selected candidates will be required to represent the Central Tax and Customs Department, Hyderabad region, in the tournament /meets as decided at least for 10 years. The selected candidates will also be required to sign an undertaking that he will not seek inter-zone transfer for a period of 10 years.

- **17.** Any form of canvassing by any candidate will render his/her candidature liable to be rejected summarily at any stage of the recruitment process.
- **18.** The Principal Commissioner of Central tax, Hyderabad GST Commissionerate has got the right to cancel the recruitment process.
- **19.** In the event of any tie the decision of the appointing authority will be final.
- **20.** This recruitment is subject to applicable rules for recruitment of meritorious sports persons, issued by Government of India from time to time.
